General

This website is globally accessible, and relates to the TopTraders platform (“**TopTraders**”), as owned by Simple2Trade (“**Simple2Trade**”, “**we**”, “**us**”, “**our**”). It concerns all Visitors to this website, and all Users (being registered customers and Users) of TopTraders.

Services

TopTraders is a platform that allows “**Hosts**” (which may include Brokers or an individual or institution that wants to host contest) to create trading contests for participants. The platform provides flexible asset class selection and winner category definition mechanism. The Hosts can decide to conduct the contest on real or virtual funds. Simple2Trade does not provide trading interface or system for the contest on real funds.

TopTraders allows “**Participants**” to participate and compete the contests created by the Hosts.

For the contest with real funds, all trading related activities will be performed on trading platforms that is preferred by the Host, not on TopTraders. In this case, TopTraders will only provide registration, participation, winner detection, other contest and related analytics services.
