Contest Rules

1. The Competition is open for both **existing** and **new sign-ups** with LIRUNEX LIMITED.
2. The Competition will be running from **16th September to 05th November 2021**.
3. Upon registration, you are deemed to comply with the rules otherwise will be ineligible.
4. The **Registration period** of this Competition closes on October 16th, 2021 23:59 (GTM+8)
5. Entrants can have only **ONE (1)** Competition live account. Subsequent entries are not eligible for the Competition live account.
6. This Competition is open to all entrants who:
 - a) are 18 years of age or above;
 - b) deem to comply with these terms and conditions; and
 - c) are not management, employees, or Promoter agents or its related entities (or immediate family members of such people) ("Eligible Entrant")

 - a) Open a **new** Lirunex live trading account. ("Competition Account")

Formula :

$$\text{ROI \%} = (\text{Total Profit} / \text{Total Deposits}) \times 100$$
